It is a pleasure to write this letter of support for the Rural and Urban Borrowing Education (RUBE) grant, as proposed by Dr. Shannon Lane and Dr. Matthew Fuller at Sam Houston State University (SHSU). The project, aimed at examining the unique challenges and opportunities rural students face in financial literacy for college going, will address an area we believe to be of critical importance for our population of students. Please allow me to discuss the kinds of support SHSU has available for this proposal as well as the need for this study.

Approximately 60% of SHSU's undergraduate student body is made up of students coming from a rural background. However, 87.9% of SHSU students accepting financial aid are from rural settings. As outlined in the proposal, prior research by Dr. Lane and Dr. Fuller has revealed a nation-wide trend in rural students using resources at a significantly lower rate than suburban and urban students. So, at a time when rural students take out loans more prevalently than urban students, they are also calling upon support services such as financial aid advising less frequently than classmates from urban areas. This study will examine why this is, in the student's own voice, and could eventually lead to further work supporting interventions for rural students.

SHSU offers its full support for this grant. If awarded, our team will work across divisions and disciplinary lines to examine the unique challenges rural students face. Under the leadership of Dr. Lane and SHSU's Center for Rural Studies—our multi-disciplinary Center focusing on studies affect rural communities and individuals—the research team will conduct qualitative interviews of rural students to learn of their needs and how they conceptualize the unique challenges they face. We anticipate this research serving as the foundation for further programs aimed at supporting rural student needs.
