





Congratulations to **Joseph Serio** whose new book, entitled *Investigating the Russian Mafia: An Introduction for Students, Law Enforcement, and International Business* has been published by Carolina Academic Press. Joe lived in the former Soviet Union for seven years and was the only American to work in the Organized Crime Control Department of the Soviet police prior to the collapse of the USSR. He later served as the director of the Moscow office of a global corporate investigation firm overseeing investigations across the former Soviet Union. Joe is a 5<sup>th</sup> year doctoral student in the College of Criminal Justice.



On March 31, Joe was interviewed about his new book on The Greater Voice radio program on the Voice America network. He was also interviewed on The Bob Cudmore Show (AM 1570 WVTL) broadcast from Amsterdam, New York, on April 8. Joe appeared in The Huntsville Item on April 10 in connection with the publication of his new book.

Mr. Serio will also be interviewed on "Voice of America," which will be broadcast in Russia and other foreign countries.





It was published by the European Institute for Crime Prevention and Control, Affiliated with the United Nations (HEUNI) in Helsinki, Finland, and the Korean Institute of Criminal Justice Policy in Seoul, Korea, 2008.

#### **Emerging Forensic Scientist**

Congratulations to Adriana Perez who has been hired as a DNA analyst with the North Louisiana Crime Lab in Shreveport, Louisiana. Adriana began the Master of Science in Forensic Science program in Fall 2006 and will graduate this May.



She completed an internship with the Austin DPS crime lab in the summer of 2006.

Graduate student Garrett Lee Burleson and his adviser, chemist Jorn Chi Chung Yu, are being credited with an inexpensive new method for identifying the presence of gunshot residue. It requires only a single speck of GSR smaller than the period at the end of this sentence and could boost the accuracy of one of the most widely used tests employed at crime scenes involving gunplay.

It extracts almost all components of gunpowder residue from particles about 15 times smaller than the width of a human hair, without the use of chemical reagents. After extraction, gas chromatography coupled with a nitrogen phosphorus detector is used to separate and identify the analytes.



"Gunshot residue tests are done in almost every case where a shooting has taken place," Burleson said. "The main focus of our research is to develop a method that will help credibility of gunshot residue evidence

in court. You can get results in 30 to 40 minutes with the new test. In addition you only need small amounts of evidence to run the test."

In an attempt to address the lack of coordination in homicide research, practical and academic homicide experts from criminology, public health, demography, geography, medicine, sociology, criminal justice, and a variety of other disciplines created the Homicide Research Working Group.
