
Meet Criminal Justice Major Rachel Schmid


#### April 6, April 20, and May 4:



#### Why file a degree plan?

Only by filing a degree plan can you officially declare Criminal Justice as your major.

#### How to file a degree plan?

- Fill out a degree plan application in the CJ Advisement Center, Room A214.
- Once your application has been processed, you will receive an email to your SHSU account notifying you to come to the advisement center to sign your Official Declaration of Major/Minor.
- Your declaration must be signed before it is processed by the Registrar's Office.

#### An official degree plan application will not be processed if a student is:

- Currently on academic probation or suspension.
- ♦ Not currently enrolled at SHSU.
- Has not completed 30 semester credit hours.
- Coursework from transfer institutions remains to be placed on the student's SHSU transcript.
