4. **Course Description:** This course is intended to give you experience embarking upon an undergraduate research project. Each student will choose a topic, research that topic, and present their research in a poster presentation, a paper, and an oral presentation. The oral presentation will be given during the student talk sessions of the Texas Section of the Mathematical Association of America in Stephenville, TX which occurs April 3-5, 2008.
5. **Course Objectives:** This course is intended to give you experience embarking upon an undergraduate research project. Classes will cover:
  - choosing a research topic
  - conducting mathematical research
  - writing an abstract
  - preparing an oral presentation
  - preparing a poster presentation
  - writing a mathematical paper (including the use of LaTeX)
6. **Required Supplies:** Students will be required to provide materials for a poster.
7. **Attendance Policy:** Students are expected to attend every class. If class must be missed, the student is expected to make an appointment with the professor. The professor will keep a record of attendance. Students are expected to arrive to class on time. Practice presentations will be made in class on certain days and it will be considered rude to interrupt a presentation by being tardy.
8. **Assignments:**

- (a) **Homework and Class Participation:** This portion of your grade is determined by your course attendance, class participation, and your ability to complete assignments by the given deadlines. For the “oral presentation” project, these deadlines are NOT negotiable, and your homework grade will suffer greatly if you miss these deadlines. As part of this grade, students are expected to participate in the constructive evaluation of posters, papers, and presentations given by other students.
- (b) **Projects:** There will be three major projects during the course of the semester - the preparation of a talk, a poster and a paper on the research topic chosen each the student. Each project will have pieces due prior to the project deadline.
9. **Final Exam:** The **final exam** will be held on Tuesday, 13 May from 2:00 - 4:00 pm. It will cover material presented by other students in the course. Each student will be asked to submit three questions about their project. The final exam will consist of questions submitted by students and questions written by the instructor.
