However, any identifying information will be kept for no more than one year. Surveys will then have all identifiers removed to maintain long-term confidentiality.

If you decide to take part in the study, it should be because you really want to volunteer. You will not lose any services, benefits, or rights you would normally have if you choose not to volunteer. As a student, if you decide not to take part in this study, your choice will have no effect on your academic status or class grade(s).

#### IS THERE ANY COMPENSATION FOR THIS STUDY

Stipends are being provided as standard incentives for student summer bridge programs and teacher workshops and museum days. Summer bridge participants will receive \$800 stipends for precipitation in the 12-day summer bridge program. Teachers will receive \$100 stipends to encourage participation in full-day workshops and museum days. Through Texas ESC, teachers may also receive continuing education credit for participating in the full workshop day.

*There is no monetary benefit for any students or teachers for taking the survey itself*, making the survey optional. Benefits are not contingent on survey completion. Project personnel will only have access to who has completed surveys, but we do not have lists or access to who has not completed surveys.

Students and teachers at open houses and classroom visits receive no monetary compensation of any kind. Food and drink may be provided at in-person open houses, access is not contingent on or related to survey completion.

#### **Informed Consent**

My name is David Moss, and I am Assistant Professor of Geology in the Department of Environmental and Geosciences at Sam Houston State University. I would like to take this opportunity to invite you to participate in a research study of geoscience perceptions of students and teachers. We hope that data from this research will provide evidence of the most effective ways to introduce students and teachers to geoscience concepts, applications, and careers. You have been asked to participate in the research because you have or will be participating in a GET Texas geoscience event.

The research is relatively straightforward, and we do not expect the research to pose any risk to any of the volunteer participants. Identifying data will be kept for one year after the surveys are completed in case follow-up questions are needed. After one year, individual survey responses will have all identifying information removed. No identifying information will be included in any research materials or publications that result from this study. Your survey responses will be kept confidential to the extent of the technology being used. Qualtrics collects IP addresses for respondents to surveys they host; however, the ability to connect your survey responses to your IP address has been disabled for this survey. That means that we will not be able to identify your responses other than through responses you choose to provide. You should keep in mind that answers to specific questions may make you more easily identifiable.
