It is a pleasure to inform you of your appointment to the interim faculty of Sam Houston State University under the terms outlined below. This appointment is a temporary non-tenure track position and is subject to the provisions of the Rules and Regulations, Board of Regents, The Texas State University System, and the Sam Houston State University Faculty Handbook. Dean Stacey L. Edmonson and Dr. Forrest C. Lane will be pleased to discuss your appointment with you should you so desire.

Your salary will be paid in equal semi-monthly installments during the period of your employment. Payroll periods for each semester are: fall semester - September 1 through January 15; spring semester - January 16 through May 31. The 2019-2020 operating budget for Sam Houston State University is subject to approval by the Board of Regents, The Texas State University System. While we do not anticipate any mid-year raises during the term of your appointment, the University reserves the right to increase your salary by an amount it determines appropriate.

This appointment is subject to and contingent upon appropriations, allotment, access and availability of state funds as provided by the Texas State Legislature and Governor.
