# **Hazing Violations**

Sam Houston State University is committed to providing a safe educational environment for everyone and does not tolerate hazing by any group or individual affiliated with the university. The university expects all students and organizations to observe and fully comply with state law and university policies associated with the prohibition of hazing.

Hazing is prohibited under state law and university policy. The university will take disciplinary action for hazing that takes place during official university functions, or during functions held by registered or sponsored student organizations. The university will also take disciplinary action for hazing incidents that have a substantial connection to the interests of the university, wherever they occur.

The internship class were asked to write 10-page papers and lined up to be yelled at by both current and former members

• Hazing, Violation of University Policy

### **University Finding(s)**

- The internship class received assignments for not doing what was instructed, following directions
- The internship class were required to complete a one (1) page paper for not creating Instagram and Twitter (X) accounts, following all current members, and gaining at least 100 followers on each platform within an instructed period of time
- One (1) intern was required to complete a ten (10) page paper for laughing during PIT

### **University Finding(s)**

- The pledge class were required to stay at the ATO house at all times with minimal exceptions for class or doctor's appointments
- The pledge class were forced to do physical exercise in the form of push-ups, sit-ups, and wall-sits
- The pledge class were required to roll in the grass after it was sprayed with a water-hose for a prolonged period
- The pledge class were required to sleep outside around a fire

- Social Probation for the spring, summer, and fall semesters of 2023
- Completion of a hazing prevention educational course
- Submission of a new member education plan

# **General Description of Incident**

 Pledges were verbally abused, forced to do physical exercise, complete a scavenger hunt, and write the fraternity letters on female's body

### Student Code of Conduct Violation(s)

• 5.2(1) Unlawful Act, 5.2(7) Endangers Others, 5.2(9) Hazing

### **University Finding(s)**

- The pledge class were verbally abused in the form of yelling and cursing, forced to arm wrestle one another, and perform physical exercise in the form of running, burpees, and push-ups
- The pledge class were required to complete a scavenger hunt retrieving several items including a urinal cake and a piece of roadkill
- The pledge class were required to locate female's, write the fraternity letters on their breast and buttocks, and have them pose for a photograph

- The pledge class were required to stay up overnight in shifts and cook a brisket
- The pledge class were required to purchase items for a tailgate with personal funds as well as tickets for other fraternity members

### **University Sanction(s)**

- Disciplinary Suspension from October 21, 2021, until May 13, 2022
- Disciplinary Probation from May 13, 2022, until May 13, 2023
- Co-host an educational program on sexual misconduct for the Greek Life Community in partnership with the Office of Title IX

- The pledge class were required to make food, do laundry, and pick up sorority members after their shift work
- The pledge class were required to download an app so sorority members could monitor their location 24/7

- A member of the pledge class was forced to kneel while another member of the fraternity picked up dog feces with a diaper and threw it in the face of the kneeling pledge class member
