RCR BASIC COURSE OVERVIEW

Listed below are the available modules within the *RCR Basic* course. The modules are designed to be applicable to researchers at any career stage. They are suitable for any person involved in research, ranging from upper-level undergraduates to established faculty. Particular emphasis is given to the educational needs of graduate students and postdoctoral researchers. An organization's module selections may vary depending on the type of research that its learners are conducting. The Help Desk can discuss specific set-up options with your organization based on its RCR training needs.

RCR REFRESHER COURSE OVERVIEW

Listed below are the available modules within the *RCR Refresher* course. The modules that an organization selects may vary depending on the type of research that its learners are conducting. If an organization wants its learners to complete refresher training, it is recommended that organizations select refresher module requirements that are similar to their selections for the basic course. A refresher course could be taken as a cycle at an interval specified by your organization (for example, three years after a learner has completed a basic RCR course). The CITI Program's Help Desk can discuss specific set-up options with your organization based on its refresher training needs.

CASE STUDIES

Most of the modules in the RCR series contain at least one case study that is embedded within the text. Most of the basic RCR modules also contain at least one video case study.

SUBSCRIPTION OPTIONS

RCR series subscriptions are available to both organizations and independent learners. Review the information below to help determine which option best meets your current needs. To discuss these options in further detail, please contact **sales@citiprogram.org**.

Organization Subscription

RCR series access is included within the CITI Program base subscription fee. Organization access allows for unlimited learner use (per site), designated administrative oversight, and the flexibility to use the courses in a number of different ways as discussed in the next section.

Independent Learner Subscription

RCR courses are available to independent learners for \$100/course. Independent learner access is intended for those not affiliated to an organization that subscribes to the CITI Program or whose organization does not offer the RCR series.

SELECTING MODULES FOR YOUR ORGANIZATION'S LEARNERS

For the RCR series, the CITI Program offers the following options for how modules are presented to learners.

- Required: A Required module must be taken in order to earn a Completion Report.
- **Elective**: A module that is associated with a set of other **Elective** modules. Learners select and complete a specified minimum number of electives from the set in order to earn a Completion Report. For example, if a learner group is required to complete three **Elective** modules, and six choices are presented, then completing any three of the six modules will allow the learner to move forward.
- Supplemental: A Supplemental module becomes available to the learner after completing any
 applicable Required and Elective modules. A learner may review Supplemental modules on a
 voluntary basis.

The selection of **Required**, **Elective**, and **Supplemental** modules is up to your organization. However, for each course, there must be at least one **Required** module.

The creation of learner groups is essential in determining which modules a learner will receive. While learner groups can be formed in multiple ways, the CITI Program offers organizations the opportunity to select pre-determined learner groups or "set-ups." Review the CITI Program's recommendations below and refer to the RCR Series Selection Form for more information.

It is important to note that organizations may also develop customized organization-specific content to supplement the training. Organizations then work with the CITI Program to develop modules that are included in learner groups for seamless delivery to learners.

Organizations may choose to create separate RCR learner groups containing only the RCR modules in any combination as noted above. Alternatively, organizations may add the RCR modules to existing learner groups. A combination of both a RCR-specific learner group and inclusion of RCR modules in existing learner groups is yet a third option for organizations.

In keeping with the options above, the CITI Program can assist administrators in creating courses (learner groups) that best meet their organizational needs, including utilizing modules from across the CITI Program. RETRAINING FREQUENCY

There is not one uniform standard regarding how frequently RCR training should occur. The National Science Foundation (NSF 2011), for example, suggests that organizations should make this determination internally. The RCR policy from the National Institutes of Health states that "Instruction must be undertaken at least once during each career stage, and at a frequency of no less than once every four years" (NIH 2009). If an organization wants its learners to complete refresher training, it is recommended that the refresher course be taken approximately three or four years after learners have completed a basic RCR course.

TRAINING METHODS

There is not a uniform standard regarding the methods and format used for RCR training. CITI Program content is designed to be a component of an overall foundation of training for an organization's affiliates. We recommend that organizations build frameworks of training that combine CITI Program content with face-to-face training, one-on-one mentoring, and other types of learning opportunities, as appropriate to the particular topics and their organizational cultures.

As with the frequency of training, the NSF (2011) suggests that organizations should make this determination internally. The NIH RCR policy prohibits a training program that relies entirely on online instruction "except in special instances of short-term training" and notes that "[a]cceptable programs generally involve at least eight contact hours" (NIH 2009). The CITI Program's RCR courses can be used to complement an in-person training experience. The courses can provide students or other researchers with a conceptual foundation that can enhance the quality of in-person training.

LANGUAGE AVAILABILITY
