# Professional Paper (Only available for students admitted prior to Fall 2014)

One requirement of the Masters of Arts Program in Sociology is developing a professional paper. The professional paper should be built on a paper written for a course you have taken at the Sociology Graduate Program. There are two types of professional papers: (1) extended literature review; and (2) original research. An extended literature review addresses a specific set of research questions in-depth. Original research is based on either primary or secondary data analysis. If you conduct original research using primary data, you must obtain IRB approval, have your data collected, analyzed, and a draft paper written *before* enrolling SOCI 5099: Professional Paper Practicum.

SOCI 5099: Professional Paper Practicum is offered in both the Fall and Spring semesters. Please note that it is not offered in summer. Thus, if an August graduation is planned, the professional paper must be completed during the Spring semester. Students are strongly encouraged to contact the Director of Graduate Studies regarding the professional paper process before the posted deadlines indicated below.

Before enrolling in SOCI 5099, students must:

- Complete at least 24 credit hours, including the three core required courses (SOCI 5310, SOCI 5312, and SOCI 5314).
- Submit a draft professional paper to the Director of Graduate Studies by October 15 for Spring and March 15 for Fall (firm deadlines; NO EXCEPTIONS)
- Once submitted, the draft will be reviewed by the Director of Graduate Studies to evaluate whether the draft meets the eligibility criteria for enrollment in SOCI 5099. To be eligible, the student's draft must at least have "1" (0-3 scale) in ALL the items of the TWO rubrics (A: Format/Quality of Writing; and B-1 or B-2: Content) linked below. If the draft does not meet the criteria, then the student cannot register for SOCI 5099.

Enrolling in the Professional Paper Practicum does not ensure the requirements for graduation have been met. The professional paper must meet the "Proficient" standard (see Grading Rubrics below) on all sections as determined by the supervising faculty.
